THE IMPACT OF CRYPTOCURRENCIES ON THE MONETARY REGULATION: A VALUE JUDGMENT

The article describes the potential impact of cryptocurrencies on the monetary regulation of central banks based on the analysis of the functions of money as a medium of exchange, a store of value and a unit of account. For each function a comparison of the economic dynamics of cryptocurrencies with fiat money is made. Cryptocurrencies is considered as a separate class of crypto assets related to "money surrogates". The emission of fiat money is carried out by the monetary authorities. On the basis of a comparative analysis, the judgment is argued about the still limited possibilities of cryptocurrencies to perform the classical functions of money and, thereby, have a (negative) impact on the effectiveness of monetary policy. At the same time, it describes the potential risks that central banks may face if the ability of fiat money to perform its functions is reduced.
