

METHODOLOGICAL ASPECTS OF STUDYING THE RESOURCE COMPONENT OF THE REGION TAKEN INTO ACCOUNT OF THE IMPACT OF SANCTIONS Annotation

The article examines the conceptual aspects of the resource component of the region and the features of sanctions shocks affecting regional dynamics. The authors conducted a comparative analysis of methodological approaches to studying the concept of "regional resources", including legal, institutional, socio-economic and environmental, structural, functional, rating, spatial and cluster aspects. STABILITY OF THE STOCK MARKET OF RUSSIAN ISSUING COMPANIES UNDER THE CONDITIONS OF CRISIS AND GLOBAL TRANSFORMATIONS

Abstract

The article proposes a methodology for assessing the stability of the economic system of stock market issuing companies based on its model – economic cenosis. With the help of rank parametric distributions of economic cenoses, an analysis of structural changes and stability of a given economic system is carried out. A dimensionless indicator of the stability of the economic cenosis of the stock market of issuing companies is presented. The developed methodology was tested on the basis of capitalization data of 100 companies listed on the Moscow Exchange from 2016 to 2022. It is shown that it is possible to carry out an investment

assessment of selected shares of issuing companies, provided that the economic system of the stock market tends to its most stable state.

TECHNOLOGICAL SOVEREIGNTY: PROBLEMS OF INTERPRETATION AND OPERATIONALIZATION OF THE CONCEPT Abstract

The presented study is devoted to the issue of interpretation and operationalization of the concept of "technological sovereignty". The author's generalizes and systematizes approaches to the interpretation of this concept that are dominant in Russian and foreign political science. An analysis of attempts to interpret and operationalize the concept within the framework of current legislation has been carried out. Technological sovereignty is defined by the author as the degree of independence of a national state from the import of technologies and products based on their use that are critical for the functioning and development of the current socio-economic model.
